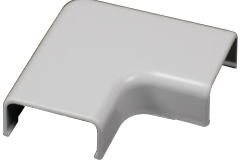
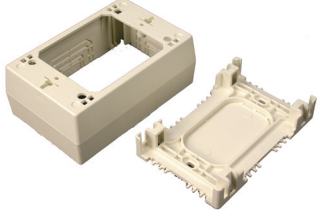

• **Theoretical recyclable potential**

The theoretical recyclable potential of a product is the percentage of material that can be recycled using existing techniques. It takes no account of the existence or lack of recycling services, which are highly dependent on the local situation.

This Reference Product contains 89% by weight of potentially recyclable material (excluding packaging):

- plastic materials : 88%
- metal materials : 1%

• **Energy recovery potential**

The process uses the converting energy contained in the waste. 88% of the product mass can be reclaimed with energy recovery.
