

SHRINK-KON® HEAT SHRINKABLE INSULATING END CAPS







MATERIAL:

Thermally stabilized, modified polyolefin, inner portion of end cap provided with factory applied sealant.

* Voltage Rating: 600 Volts Max.

* Temperature Rating: 90°C Max.

* Flame retardant.

INSTALLATION INSTRUCTIONS:

- 1. Slide expanded heat shrinkable cap over item to be covered.
- Shrink the cap by applying heat, using a torch (Catalog Number SIT-1) or hot air blower (heat gun TBM750F or WT1400), or equivalent heat source. Tubing starts to shrink at 250-275°F.
 CAUTION: KEEP HANDS AWAY FROM TORCH OR HEAT SOURCE.
- 3. Shrink the cap from the closed end toward the open end. As heat is applied, move heat source around the cap to be shrunk. THIS WILL ENSURE EVEN SHRINKAGE.
- 4. When the cap has been recovered (shrunk) enough to conform to the shape of the item covered and sealant is seen to flow, discontinue heating.
