CCC Waiver for Product of PD PA CI

Dear Sirs,

The requirement of having to provide a CCC certificate for a product depends on the HS code of each individual product. Most products of PD PA CI do not require the CCC certificate but have been applied for a CCC waiver, i.e. products of / for

- Communication for PLC and Telecontrol,
- Communication for PC / IPC
- Industrial network components including WLAN and Wireless HART
- Industrial Identification including HF-, UHF-RFID, Transponders, Machine Vision and Communication Modules

Currently, there are only few PD PA CI products for which it is known to PD PA CI that a CCC certificate is required:

Modems / Routers / Communication processors / RTUs which provide radio telecommunication interfaces such as GSM / GPRS, UMTS, LTE.

For providing support to the clearing process of Chinese Customs Siemens Ltd., China Export Control and Customs, applies for so-called CCC waivers. For products with granted CCC waivers the order numbers (MLFBs) of the corresponding products are entered in a file of the Chinese Entry-Exit Inspection and Quarantine Bureau.

In case the Chinese Customs clearing process for products with CCC waivers proves to be difficult please feel free to get in touch with the product management for support.
