



Position of Cable Gland

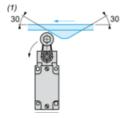




