
**Description of the product**

Switch on and off during 20 years electrical power supply of a downstream installation with an electrical and/or mechanical control. The functional unit is characterized by a type 1 NO+1 NC, a control circuit voltage 110V DC, a power circuit voltage 690V and a rated operational current 9A.


